## \*\*Parish Activity Status Report: -- Fr. Becker

- -- <u>Deposit & Loan Services:</u> As the Diocese has ceased these services, all accounts must now be transferred to local financial institutions and overseen by Parish personnel. A sub-committee headed by Don Dose, will be formed to look into our options and recommend actions to be taken.
- -- <u>Lawn Equipment Purchase:</u> A new 24 HP John Deere garden tractor with snow blower and belly pan mower was purchased for \$8,724 and the Cemetery Assoc. purchased the old one for \$1,750, lowering the cost to \$6,974. We will also attempt to sell another one that we still own.
- -- <u>Budgeting Process:</u> 2% cost-of-living increase for Staff was included in final budget. Motion to approve budget for 2015/2016...Made by Hanna Krenik. Seconded by John Lubinski... Passed
- -- New Smart Phone: Fr. Becker has a new smart phone and asks for additional reimbursement of \$13 per month above his old phone. Motion to increase reimbursement to 2/3 of total cost of \$80 (= \$53.33 per month). Made by Bill Huber. Seconded by John Lubinski.. Passed

## \*\*Building & Grounds Report: -- Don Dose

- -- Church Roof and Eave Trough Leak Repair: Repairs on the Church roof have been completed by David Schumacher and no leaks have appeared during these last weeks of wet weather. Costs are as follows: Nickelson (for lift) \$934 (paid in June), KBS (shingles) \$1,185.82 (paid in June), KBS (misc. for roof repair) \$71.88 & \$27.96 (paid in June), David Schumacher- Donated his services.
- -- Church Interior Ceiling Repair: Bruce Hanson or a contractor will be contacted to do the repair work.
- -- Missing shingles on steeples: Krause Konstruction Company \$8,870 (paid in June)
- --North Church Entry Upper Roof Repair: Membrane roof where Church Air Compressors are located, is being pushed up by screws coming out of roof boards beneath it. Building & Grounds Cmte. must discuss.
- -- <u>Church Chimneys:</u> Building & Grounds Committee will be asked to review options of either removing the chimneys or tuck pointing them before they fall and damage the Church roof.
