The parishioner then uses the scrip "at face value" to purchase products from the business. We are still considering the value of such an arrangement..

- -- <u>Church Chimneys:</u> Krause Konstruction Company bid was accepted. Next spring, the two chimneys are to be removed "to roof line" and holes to be framed and sheeted. Matching Decra shingles to cover the sheeting.
- -- <u>Furnaces & A/C Unit Replacements:</u> Rahman Heating's bid of \$47,850 to install 4 furnaces with side venting, 6 A/C units and 4 Air Handlers including disposal was accepted previously. No update at this time.
- -- <u>Carport Upper Roof:</u> Reviewed bids and decided to repair areas rather than replace all the roofing. Motion to accept Schwickert's bid of \$3,825 to repair carport upper central area.
